Definitions

1. **Adoption** shall refer to the act of adopting, in reference to Jen's Kitty Rehab, hereafter known as JKR, adoption means to take and care for the cat(s) by formal act. All adoptions must be approved through JKR and expectations of adoption are detailed later on in this document.
2. **Appropriate**, as in, appropriate home, shall be one that follows all adoption and/or fostering guidelines set by JKR. Should the applicant live in a rental, they must have a landlord that would agree to allow the adoption and/or fostering of the cat(s).
3. **Declawed** shall refer to the act of surgically amputation the entire distal phalanx of an animal's toes.
4. **Document** refers separately and collectively to any information stored in any form on any format.
5. **Facebook** shall refer to the social media platform.
6. **Financial Resources** shall refer to the ability to care, feed, and provide for the cat(s). Applicants are expected to use veterinarians pre-approved by JKR.
7. **Foster** shall refer to the act of taking a cat into your home and providing care and attention, until the cat is adopted or for a predetermined period of time.
8. **Foster Agreement** shall refer to the agreement between the foster applicant and JKR that specifies the conditions for care and control of the foster cat.
9. **Homeowner** shall refer to the person who owns a home, specifically the home in which the cat from JKR would or will reside.
10. **Home Visit** shall refer to the act of a member of JKR visiting the home to assess the conditions and the capabilities of the foster or adoptive family of providing the best care of the cat(s) from JKR.
11. **Notice** shall refer to the act of contacting a representative of JKR to give warning and allow preparation.
12. **Pet** shall refer to any domestic or tamed animal kept for comfort or companionship.
13. **Records** shall refer to any form of documentation, including but not limited to veterinary records.
14. **Renting** shall refer to the act of paying someone for the use of land or a residence.

15. **Residence** shall refer to the home wherein the applicant lives.
16. **Restrictions** shall refer to the limitation on activity, by statute, regulation, or contract provision.
17. **Spayed/Neutered** shall refer to the act of sterilization by removal of an animal's reproductive organ, either all of it or a considerably large part.
18. **Surrender** shall refer to the act of relinquishment.
19. **Vaccinations** shall refer to the act of inoculation to provide immunity against a disease.
20. **Veterinarian** shall refer to a person who is authorized and qualified to treat diseases and injuries of domestic animals, surgically and/or medically.

I understand that my application can be denied for any reason by any representative of JKR and that JKR reserves the right to share that reason with me or not.

I understand that I need to have Facebook access so that I can communicate with representatives of JKR. I agree that if I do not have a Facebook account that I am obligated to report any changes in my contact information within twenty-four hours of those changes being made or I forfeit my right to foster and/or adopt from JKR.

I agree to use the veterinarian suggested to me by JKR and to maintain any necessary medical attention that my foster cat may

require, including vaccinations. I agree to ensure that any cat that I foster from JKR will receive regular heartworm prevention treatment. I agree not to declaw the cat that I foster from JKR. I agree to register any JKR foster cat(s) in my care under the name of Jen's Kitty Rehab, when and where possible.

I agree to keep all new foster cat(s) separated from any other animals for the first fourteen days of caring for them.

I agree to notify a representative of JKR immediately should I not be able to adequately provide for the foster cat or need to surrender it. I understand that I cannot rehome the foster cat from JKR and that I must return it to JKR should the need arise. I understand that I cannot return the cat(s) without first contacting JKR and making arrangements.

I understand that JKR cannot make a guarantee regarding the temperament or health of a cat. I acknowledge that upon approval, I will be given the available medical history of the cat(s) that I foster.

I consent to home visits during my time as a foster parent with JKR provided that proper notice has been given.

I hereby certify that to the best of my knowledge, all information provided to JKR is truthful and that it is my responsibility to notify JKR of any changes or any answers. I understand that my failure to do so may forfeit my right to foster or adopt with JKR.
